





Air Quality

Air quality management area

The property is within an Air Quality Management Area.

Guidance: Since December 1997 each Local Authority in the UK has been carrying out a review and assessment of air quality in their area. This involves measuring air pollution and trying to predict how it will change in the next few years. The map for each year is modelled based on air quality monitoring and meteorological data. The maps divide the country into sectors. The concentrations for each sector account for pollution emitted within the sector itself and pollution that arrives from elsewhere, for example blown in by the wind.
